QUALIFICATION FOR WHOLESALE PURCHASE PRIVILEGES

PLEASE READ THIS PAGE CAREFULLY BEFORE CONTINUING

Ensign Wholesale Floral provides cut flowers, artificial flowers, and floral supplies, holiday and seasonal decorations and home accessories on a WHOLESALE basis to qualified businesses in the industry. In order to protect the integrity of our wholesale pricing and distribution policies, it is necessary that we limit the sale of our products to those businesses that meet the following qualifications.

- 1) Business must provide a copy of valid business license issued by the proper local authority.
- 2) Business must provide a copy of a valid re-sale certificate, issued by the appropriate state agency, complete with re-sale number.*
- 3) Purchases must be made for resale or redistribution to others in the furtherance of your business.
- 4) Qualifying businesses generally include the following: retail florists; interior decorators & designers; wedding planners, consultants, & suppliers; reception centers; caterers; special event producers; interior landscapers; decorating and display companies. In other words, businesses that can be reasonably expected to actively resell products purchased from Ensign.
- 5) Accompanying application must be completed and approved by management.

Ensign Wholesale Floral reserves the right to refuse wholesale purchase privileges to non-qualifying businesses and/or restrict the categories of merchandise and/or the price charged in order to protect the interests of our qualifying clientele.

If your business does not qualify for an account under the criteria listed above, we encourage you to patronize our retail customer's shops. Many of them offer special commercial pricing.

***A Note About Resale Numbers and Sales Tax.**

A resale number is required to help us verify the existence and suitability of your business for wholesale purchase privilege. Only valid Utah resale numbers provide relief from the payment of Utah sales tax. Resale numbers from other states do not relieve Ensign of the duty to collect Utah sales tax. Any transaction completed in Utah, regardless of the intent of the purchaser to resell the purchased items, must be charged Utah sales tax in the absence of a valid Utah resale certificate. Items shipped to other states are exempt from Utah sales tax but may be subject to tax in the destination state.
